

FY25 EU (Spain only) PCBCR data in line with Chapter 10a of Directive 2013/34/EU

The data set out below is published on behalf of Select Service Partner Spain Financing SLU, SSP Airport Restaurants SL, Foodlasa SL and Select Service Partner SAU (hereinafter, the "SSP entities in Spain") to meet the Public Country by Country Reporting requirements as required in Spain by the Eleventh Additional Provision ("11th AP") of Law 22/2015.

It is approved by the Directors of Select Service Partner Spain Financing SLU as the entity which control the other entities referred to above.
