PRELIMINARY

Exclusion of other regulations 1. This document comprises the Articles of Association of the Company and no regulations set out in any statute or statutory instrument concerning companies shall apply as Articles of Association of the Company.

Definitions 2. In these Articles, except where the subject or context otherwise requires:

Act means the Companies Act 2006 including any modification or re-enactment of it for the time being in force;

Articles means these articles of association as altered from time to time by special resolution;

auditors means the auditors of the Company;

the board means the directors or any of them acting as the board of directors of the Company;

certificated share means a share ~~in the capital of the Company~~ that is not an uncertificated share and references in these Articles to a share being held in certificated form shall be construed accordingly;

clear days in relation to the sending of a notice means the period excluding the day on which a notice is given or deemed to be given and the day for which it is given or on which it is to take effect;

~~*Deferred Shares* means the deferred shares in the capital of the Company having the rights set out in these Articles;~~

Company's website means the website, operated or controlled by the Company, which contains information about the Company in accordance with the Act;

~~*Deferred Shareholder* means any person entered in the register of members of the Company as the holder for the time being of any Deferred Shares;~~

director means a director of the Company;

dividend means dividend or bonus;

entitled by transmission means, in relation to a share ~~in the capital of the Company~~, entitled as a consequence of the death or bankruptcy of the holder or otherwise by operation of law;

holder in relation to a share ~~in the capital of the Company~~ means the member whose name is entered in the register as the holder of that share;

Information Rights has the meaning given to such expression in section 146(3) of the Act;

member means a member of the Company;

Nomination Notice means a notice given by a member to the Company that another person is entitled to enjoy Information Rights and to receive Shareholder Information which that member is entitled to enjoy or to receive;

office means the registered office of the Company;

~~*Ordinary Shares* means the ordinary shares in the share capital of the Company;~~

Operator means a person operating a relevant system for the purposes of the Regulations;

~~*Ordinary Shareholder* means a person entered in the register of members of the Company as the holder for the time being of Ordinary Shares;~~

paid means paid or credited as paid;

participating security means a participating security for the purposes of the Regulations;

recognised person means a recognised clearing house or a nominee of a recognised clearing house or of a recognised investment exchange, each of which terms has the meaning given to it by section 778 of the Act;

register means either or both of the issuer register of members and the Operator register of members of the Company;

Regulations means the Uncertificated Securities Regulations 2001 including any modification or re-enactment of them for the time being in force;

seal means the common seal of the Company and includes any official seal kept by the Company by virtue of section 49 or 50 of the Act;

secretary means the secretary of the Company and includes a joint, assistant, deputy or temporary secretary and any other person appointed to perform the duties of the secretary;

share means a share in the capital of the Company;

Shareholder Information means notices, documents or information which the Company wishes or is required to communicate to holders including, without limitation, annual reports and accounts, interim financial statements, summary financial statements, notices of meetings and proxy forms;

uncertificated share means (subject to Regulation 42(11)(a) of the Regulations) a share ~~in the capital of the Company~~ title to which is recorded on the Operator register of members of the Company and which may, by virtue of the Regulations, be transferred by means of a relevant system and references in these Articles to a share being held in uncertificated form shall be construed accordingly; ~~and~~

United Kingdom means Great Britain and Northern Ireland~~;~~

website communication means the publication of a notice or other Shareholder Information on the Company's website in accordance with Part 4 of Schedule 5 to the Act; and

working day means a day, except a Saturday, Sunday or any day that is a bank holiday under the Banking and Financial Dealings Act 1971 (c80) in England and Wales, on which banks are open for general business in London.

Construction

3. Where, in relation to a share, these Articles refer to a **relevant system**, the reference is to the relevant system in which that share is a participating security at the relevant time.

References to a document or information being **sent, supplied or given** to or by a person mean such document or information, or a copy of such document or information, being sent, supplied, given, delivered, issued or made available to or by, or served on or by, or deposited with or by that person by any method authorised by these Articles, and **sending, supplying** and **giving** shall be construed accordingly.

References to *writing* mean the representation or reproduction of words, symbols or other information in a visible form by any method or combination of methods, whether sent or supplied in electronic form or otherwise, and *written* shall be construed accordingly.

Nothing in these Articles shall preclude the holding and conducting of a meeting in such a way that persons who are not present together at the same place may by electronic means attend and speak and vote at it.

References to *electronic facility* mean a device, system, procedure, method or facility providing an electronic means of attendance at or participation in (or both attendance at and participation in) a general meeting determined by the board pursuant to Article 59.

Words denoting the singular number include the plural number and vice versa; words denoting ~~the masculine~~ one gender shall (where appropriate) include ~~the feminine~~ any other gender; and words denoting persons include ~~corporations~~ references to bodies corporate and to unincorporated bodies of persons.

Any words or expressions defined in the Act or the Regulations (as in force at the time of adoption of these Articles) shall, if not inconsistent with the subject or context and unless otherwise expressly defined in these Articles, bear the same meaning in these Articles save that the word *company* shall include any body corporate.

~~Words or expressions contained in these Articles which are not defined in Article 2 but are defined in the Act have the same meaning as in the Act (but excluding any modification of the Act not in force at the date these Articles took effect) unless inconsistent with the subject or context.~~

~~Words or expressions contained in these Articles which are not defined in Article 2 but are defined in the Regulations have the same meaning as in the Regulations (but excluding any modification of the Regulations not in force at the date of adoption of these Articles) unless inconsistent with the subject or context.~~

Subject to the preceding two paragraphs, references to any provision of any enactment or of any subordinate legislation (as defined by section 21(1) of the Interpretation Act 1978) include any modification or re-enactment of that provision for the time being in force.

Headings and marginal notes are inserted for convenience only and do not affect the construction of these Articles.

In these Articles, (a) powers of delegation shall not be restrictively construed but the widest interpretation shall be given to them; (b) the word *board* in the context of the exercise of any power contained in these Articles includes any committee consisting of one or more directors, any director, any other officer of the Company and any local or divisional board, manager or agent of the Company to which or, as the case may be, to whom the power in question has been delegated; (c) no power of delegation shall be limited by the existence or, except where expressly provided by the terms of delegation, the exercise of that or any other power of delegation; and (d) except where expressly

provided by the terms of delegation, the delegation of a power shall not exclude the concurrent exercise of that power by any other body or person who is for the time being authorised to exercise it under these Articles or under another delegation of the power.

References to:

- (a) *mental disorder* mean mental disorder as defined in section 1 of the Mental Health Act 1983 or the Mental Health (Scotland) Act 1984 (as the case may be);
- (b) any statute, regulation or any section or provision of any statute or regulation, if consistent with the subject or context, shall include any corresponding or substituted statute, regulation or section or provision of any amending, consolidating or replacement statute or regulation;
- (c) *executed* include any mode of execution;
- (d) an Article by number are to a particular Article of these Articles;
- (e) a *meeting* shall be taken as not requiring more than one person to be present if any quorum requirement can be satisfied by one person;
- (f) a share (or to a holding of shares) being in uncertificated form or in certificated form are references respectively to that share being an uncertificated unit of a security or a certificated unit of a security; and

SHARE CAPITAL AND LIMITED LIABILITY

Limited liability 4. The liability of the members is limited to the amount, if any, unpaid on the shares held by them.

Shares with special rights 5. Subject to the provisions of the Act and without prejudice to any rights attached to any existing shares or class of shares, any share may be issued with such rights or restrictions as the Company may by ordinary resolution determine or, subject to and in default of such determination, as the board shall determine. Such rights and restrictions shall apply to the relevant shares as if the same were set out in these Articles.

Share warrants to bearer ~~4. The board may issue share warrants to bearer in respect of any fully paid shares under a seal of the Company or in any other manner authorised by the board. Any share while represented by such a warrant shall be transferable by delivery of the warrant relating to it. In any case in which a warrant is so issued, the board may provide for the payment of dividends or other moneys on the shares represented by the warrant by coupons or otherwise. The board may decide, either generally or in any particular case or cases, that any signature on a warrant may be applied by electronic or mechanical means or printed on it or that the warrant need not be signed by any person.~~

Conditions of issue of share warrants

~~5. The board may determine, and from time to time vary, the conditions on which share warrants to bearer shall be issued and, in particular, the conditions on which:~~

~~(a) a new warrant or coupon shall be issued in place of one worn out, defaced, lost or destroyed (but no new warrant shall be issued unless the Company is satisfied beyond reasonable doubt that the original has been destroyed); or~~

~~(b) the bearer shall be entitled to attend and vote at general meetings; or~~

~~(c) a warrant may be surrendered and the name of the bearer entered in the register in respect of the shares specified in the warrant.~~

~~The bearer of such a warrant shall be subject to the conditions for the time being in force in relation to the warrant, whether made before or after the issue of the warrant. Subject to those conditions and to the provisions of the Act, the bearer shall be deemed to be a member of the Company and shall have the same rights and privileges as he would have if his name had been included in the register as the holder of the shares comprised in the warrant.~~

No right in relation to share

~~6. The Company shall not be bound by or be compelled in any way to recognise any right in respect of the share represented by a share warrant other than the bearer's absolute right to the warrant.~~

Uncertificated shares

~~6.~~ 7. Subject to the provisions of the Regulations, the board may permit the holding of shares in any class of shares in uncertificated form and the transfer of title to shares in that class by means of a relevant system and may determine that any class of shares shall cease to be a participating security.

Change in form of shares

7. Where any class of shares is, for the time being, a participating security (such class being referred to in these Articles as the *Relevant Class*), shares of the Relevant Class may be changed from uncertificated to certificated form, and from certificated to uncertificated form, in accordance with and subject as provided in the Regulations. Unless the board otherwise determines, shares of the Relevant Class held by the same holder or joint holder in certificated form and uncertificated form shall be treated as separate holdings.

Not separate class of shares

~~8.~~ 8. Shares ~~in the capital of the Company~~ that fall within a certain class shall not form a separate class of shares from other shares in that class because any share in that class:

(a) is held in uncertificated form; or

(b) is permitted in accordance with the Regulations to become a participating security.

Exercise of Company's entitlements in respect of uncertificated share

9. ~~9.~~ Where any class of shares is a participating security and the Company is entitled under any provision of the Act, the Regulations or these Articles to sell, transfer or otherwise dispose of, forfeit, re-allot, accept the surrender of, or otherwise enforce a lien over, a share held in uncertificated form, the Company shall be entitled, subject to

the provisions of the Act, the Regulations, these Articles and the facilities and requirements of the relevant system:

- (a) to require the holder of that uncertificated share by notice to change that share into certificated form within the period specified in the notice and to hold that share in certificated form so long as required by the Company;
- (b) to require the holder of that uncertificated share by notice to give any instructions necessary to transfer title to that share by means of the relevant system within the period specified in the notice;
- (c) to require the holder of that uncertificated share by notice to appoint any person to take any step, including without limitation the giving of any instructions by means of the relevant system, necessary to transfer that share within the period specified in the notice;
- (d) to require the Operator to convert that uncertificated share into certificated form in accordance with Regulation 32(2)(c) of the Regulations; and
- (e) to take any action that the board considers appropriate to achieve the sale, transfer, disposal, forfeiture, re-allotment or surrender of that share, or otherwise to enforce a lien in respect of that share.

authority~~

~~10.—The board has general and unconditional authority to exercise all the powers of the Company to allot shares in the Company or to grant rights to subscribe for or to convert any security into shares in the Company up to an aggregate nominal amount equal to the section 551 amount, for each prescribed period.~~

~~Section 561
disapplication~~

~~11.—The board is empowered for each prescribed period to allot equity securities for cash pursuant to the authority conferred by Article 12 as if section 561 of the Act did not apply to any such allotment, provided that its power shall be limited to:~~

- ~~(a) the allotment of equity securities in connection with a pre-emptive issue; and~~
- ~~(b) the allotment (otherwise than pursuant to Article 13(a)) of equity securities up to an aggregate nominal amount equal to the section 561 amount.~~

~~This Article applies in relation to a sale of shares which is an allotment of equity securities by virtue of section 560(3) of the Act as if in this Article the words “pursuant to the authority conferred by Article 12” were omitted.~~

~~Allotment after
expiry~~

~~12.—The Company may make an offer or agreement which would or might require shares to be allotted, or rights to subscribe for or convert any security into shares to be granted, after an authority given pursuant to Article 12 or a power given pursuant to Article 13 has expired. The board may allot shares, or grant rights to subscribe for or convert any security into shares, in pursuance of that offer or agreement as if the authority or power pursuant to which that offer or agreement was made had not expired.~~

~~Definitions~~

~~13.—In this Article and Articles 12, 13 and 14:~~

~~*pre-emptive issue* means an offer of equity securities to Ordinary Shareholders or an invitation to Ordinary Shareholders to apply to subscribe for equity securities and, if in accordance with their rights the board so determines, holders of other equity securities of any class (whether by way of rights issue, open offer or otherwise) where the equity securities respectively attributable to the interests of Ordinary Shareholders or holders of other equity securities, if applicable are proportionate (as nearly as practicable) to the respective numbers of Ordinary Shares or other equity securities, as the case may be held by them, but subject to such exclusions or other arrangements as the board may deem necessary or expedient in relation to fractional entitlements or any legal, regulatory or practical problems under the laws or regulations of any territory or the requirements of any regulatory body or stock exchange;~~

~~*prescribed period* means any period for which the authority conferred by Article 12 is given by ordinary or special resolution stating the section 551 amount and/or the power conferred by Article 13 is given by special resolution stating the section 561 amount;~~

~~*section 551 amount* means, for any prescribed period, the amount stated as such in the relevant ordinary or special resolution; and~~

**Residual
allotment Share
dealing powers**

10. ~~14.~~ Subject to the provisions of the Act relating to authority, pre-emption rights or otherwise, ~~these Articles~~ and ~~of~~ any resolution of the Company in general meeting passed pursuant to those provisions, and, in the case of redeemable shares, the provisions of Article ~~17:~~11, and without prejudice to the rights attaching to any existing shares or class of shares, the board may offer, allot (with or without a right of renunciation), issue, grant options over, reclassify or otherwise deal with or dispose of shares to such persons, at such time and for such consideration and upon such terms and conditions as the Board may determine.

~~(a) — all shares for the time being in the capital of the Company shall be at the disposal of the board; and~~

~~(b) the board may reclassify, allot (with or without conferring a right of renunciation), grant options over, or otherwise dispose of them to such persons on such terms and conditions and at such times as it thinks fit.~~

**Redeemable
shares**

11. ~~15.~~ Subject to the provisions of the Act, and without prejudice to any rights attached to any existing shares or class of shares, shares may be issued which are to be redeemed or are to be liable to be redeemed at the option of the Company or the holder. The board may determine the terms, conditions and manner of redemption of shares provided that it does so before the shares are allotted.

Commissions

12. ~~16.~~ The Company may exercise all powers of paying commissions or brokerage conferred or permitted by the Act. Subject to the provisions of the Act, any such commission or brokerage may be satisfied by the payment of cash or by the allotment of fully or partly paid shares or partly in one way and partly in the other.

Trusts not recognised

13. ~~17.~~ Except as required by law, the Company shall recognise no person as holding any share on any trust and (except as otherwise provided by these Articles or by law) the Company shall not be bound by or recognise any interest in any share (or in any fractional part of a share) except the holder's absolute right to the entirety of the share (or fractional part of the share).

Deferred Shares

Rights attaching to Deferred Shares

~~18. — The Deferred Shares shall not entitle the Deferred Shareholders to receive notice of or to attend or vote at any general meeting of the Company or (subject to the Act) at any meeting of the holders of any class of shares in the capital of the Company by virtue of their holdings of any such Deferred Shares.~~

Automatic transfer of Deferred Shares

~~19. — Immediately following the adoption of these Articles, any Deferred Shares in issue as at the date of adoption of these Articles shall be automatically transferred to Trustcorp (Jersey) Limited for nil consideration. To give effect to any transfer of Deferred Shares from a Deferred Shareholder to Trustcorp (Jersey) Limited required pursuant to this Article, the Company may appoint any person as attorney for the Deferred Shareholder to transfer the Deferred Shares to Trustcorp (Jersey) Limited and do all such other things and execute and deliver all such documents as may in the opinion of the attorney or Trustcorp (Jersey) Limited be necessary or desirable to vest the Deferred Shares in Trustcorp (Jersey) Limited.~~

No Deferred Share certificates

~~20. — Notwithstanding Article 25, the Company shall not be obliged to issue a certificate to any Deferred Shareholder or Trustcorp (Jersey) Limited for any Deferred Shares.~~

VARIATION OF RIGHTS

Method of varying rights

14. ~~21.~~ Subject to the provisions of the Act, if at any time the capital of the Company is divided into different classes of shares, the rights attached to any class may (unless otherwise provided by the terms of allotment of the shares of that class) be varied or abrogated, whether or not the Company is being wound up, either:

- (a) with the written consent of the holders of three-quarters in nominal value of the issued shares of the class (excluding any shares of that class held as treasury shares), which consent shall be in hard copy form or in electronic form sent to such address (if any) for the time being specified by or on behalf of the Company for that purpose, or in default of such specification to the office, and may consist of several documents, each executed or authenticated in such manner as the board may approve by or on behalf of one or more holders, or a combination of both; or
- (b) with the sanction of a special resolution passed at a separate general meeting of the holders of the shares of the class,

but not otherwise.

When rights deemed to be varied

15. ~~22.~~ For the purposes of Article ~~23~~14, if at any time the capital of the Company is divided into different classes of shares, unless otherwise expressly provided by the rights attached to any share or class of shares, those rights shall be deemed to be varied by:

- (a) the reduction of the capital paid up on that share or class of shares otherwise than by a purchase or redemption by the Company of its own shares; and
- (b) the allotment of another share ranking in priority for payment of a dividend or in respect of capital or which confers on its holder voting rights more favourable than those conferred by that share or class of shares,

but shall not be deemed to be varied by:

- (c) the creation or issue of another share ranking equally with, or subsequent to, that share or class of shares or by the purchase or redemption by the Company of its own shares; or
- (d) the Company permitting, in accordance with the Regulations, the holding of and transfer of title to shares of that or any other class in uncertificated form by means of a relevant system.

SHARE CERTIFICATES

Members' rights to certificates

16. ~~23.~~ ~~Subject to Article 22, every~~ Every member, on becoming the holder of any certificated share (except a recognised person in respect of whom the Company is not required by law to complete and have ready for delivery a certificate) shall be entitled, without payment, to one certificate for all the certificated shares of each class held by ~~him~~ the member (and, on transferring a part of ~~his~~ the member's holding of certificated shares of any class, to a certificate for the balance of ~~his~~ the member's holding of certificated shares). ~~He~~ The member may elect to receive one or more additional certificates for any of ~~his~~ the member's certificated shares if ~~he~~ the member pays a reasonable sum determined from time to time by the board for every certificate after the first. Every certificate shall:

- (a) having regard to the Act and any regulatory requirements, be executed under the seal or otherwise in accordance with Article ~~175~~ 185 or in such other manner as the board may approve; and
- (b) specify the number, class and distinguishing numbers (if any) of the shares to which it relates and the amount or respective amounts paid up on the shares.

Any two or more certificates representing shares of any one class held by any member may at the member's request be cancelled and a single new certificate for such shares issued in lieu without charge. In the case of shares held jointly by several person, any such request may only be made by the joint holder who is named first in the register.

The Company shall not be bound to issue more than one certificate for certificated shares held jointly by more than one person and delivery of a certificate to one joint

holder shall be a sufficient delivery to all of them. Shares of different classes may not be included in the same certificate.

Replacement certificates

17. ~~24.~~ If a share certificate is defaced, worn out, lost or destroyed, it may be renewed on such terms (if any) as to evidence and indemnity and payment of any exceptional out-of-pocket expenses reasonably incurred by the Company in investigating evidence and preparing the requisite form of indemnity as the board may determine but otherwise free of charge, and (in the case of defacement or wearing out) on delivery up of the old certificate.

LIEN

Company to have lien on shares

18. ~~25.~~ The Company shall have a first and paramount lien on every share (not being a fully paid share) for all moneys payable to the Company (whether presently or not) in respect of that share. The board may at any time (generally or in a particular case) waive any lien or declare any share to be wholly or in part exempt from the provisions of this Article. The Company's lien on a share shall extend to any amount (including without limitation dividends) payable in respect of it.

Enforcement of lien by sale

19. ~~26.~~ The Company may sell, in such manner as the board determines, any share on which the Company has a lien if a sum in respect of which the lien exists is presently payable and is not paid within 14 clear days after notice has been sent to the holder of the share, or to the person entitled to it by transmission, demanding payment and stating that if the notice is not complied with the share may be sold.

Giving effect to sale

20. ~~27.~~ To give effect to that sale the board may, if the share is a certificated share, authorise any person to execute an instrument of transfer in respect of the share sold to, or in accordance with the directions of, the buyer. If the share is an uncertificated share, the board may exercise any of the Company's powers under Article ~~11-9~~ to effect the sale of the share to, or in accordance with the directions of, the buyer. The buyer shall not be bound to see to the application of the purchase money and ~~his~~ their title to the share shall not be affected by any irregularity in or invalidity of the proceedings in relation to the sale.

Application of proceeds

21. ~~28.~~ The net proceeds of the sale, after payment of the costs, shall be applied in or towards payment or satisfaction of so much of the sum in respect of which the lien exists as is presently payable. Any residue shall (if the share sold is a certificated share, on surrender to the Company for cancellation of the certificate in respect of the share sold -, or the provision of such evidence or indemnity as the board may think fit. and, whether the share sold is a certificated or uncertificated share, subject to a like lien for any moneys not presently payable as existed on the share before the sale) be paid to the holder of (or person entitled to by transmission to) the share at the date of the sale.

CALLS ON SHARES

Power to make calls

22. ~~29.~~ Subject to the terms of allotment, the board may from time to time make calls on the members in respect of any moneys unpaid on their shares (whether in respect of nominal value or premium). Each member shall (subject to receiving at least 14 clear days' notice specifying when and where payment is to be made) pay to the Company the amount called on ~~his~~ their shares as required by the notice. A call may

be required to be paid by instalments. A call may be revoked in whole or part and the time fixed for payment of a call may be postponed in whole or part as the board may determine. A person on whom a call is made shall remain liable for calls made on ~~him~~ that person even if the shares in respect of which the call was made are subsequently transferred.

Time when call made 23. ~~30.~~ A call shall be deemed to have been made at the time when the resolution of the board authorising the call was passed.

Liability of joint holders 24. ~~31.~~ The joint holders of a share shall be jointly and severally liable to pay all calls in respect of it.

Interest payable 25. ~~32.~~ If a call or any instalment of a call remains unpaid in whole or in part after it has become due and payable the person from whom it is due and payable shall pay interest on the amount unpaid from the day it became due and payable until it is paid. Interest shall be paid at the rate fixed by the terms of allotment of the share or in the notice of the call or, if no rate is fixed, the rate determined by the board, not exceeding 15 per cent. per annum, or, if higher, the appropriate rate (as defined in the Act), but the board may in respect of any individual member waive payment of such interest wholly or in part.

Deemed calls 26. ~~33.~~ An amount payable in respect of a share on allotment or at any fixed date, whether in respect of nominal value or premium or as an instalment of a call, shall be deemed to be a call duly made and notified and payable on the date so fixed or in accordance with the terms of the allotment. If it is not paid the provisions of these Articles shall apply as if that amount had become due and payable by virtue of a call duly made and notified.

Differentiation on calls 27. ~~34.~~ Subject to the terms of allotment, the board may make arrangements on the issue of shares for a difference between the allottees or holders in the amounts and times of payment of calls on their shares.

Payment of calls in advance 28. ~~35.~~ The board may, if it thinks fit, receive from any member all or any part of the moneys uncalled and unpaid on any share held by him. Such payment in advance of calls shall extinguish the liability on the share in respect of which it is made to the extent of the payment. The Company may pay on all or any of the moneys so advanced (until they would but for such advance become presently payable) interest at such rate agreed between the board and the member not exceeding (unless the Company by ordinary resolution otherwise directs) 15 per cent. per annum or, if higher, the appropriate rate (as defined in the Act).

FORFEITURE AND SURRENDER

Notice requiring payment of call 29. ~~36.~~ If a call or any instalment of a call remains unpaid in whole or in part after it has become due and payable, the board may give the person from whom it is due not less than 14 clear days' notice requiring payment of the amount unpaid together with any interest which may have accrued and any costs, charges and expenses incurred by the Company by reason of such non-payment. Form and execution of transfer of certificated share

36. ~~43.~~ Without prejudice to any power of the Company to register as shareholder a person to whom the right to any share has been transmitted by operation of law, ~~the certificated shares may be transferred by way of an instrument of transfer of a certificated share may be in any usual form~~ or in any other form which the board may approve. An instrument of transfer shall be ~~signed~~ executed by or on behalf of the transferor and, unless the share is fully paid, by or on behalf of the transferee. An instrument of transfer need not be under seal.

Transfers of partly paid shares
Refusal to register transfers of certificated shares
Invalid transfers of certificated shares

37. ~~44.~~ The board may, in its absolute discretion, refuse to register the transfer of a certificated share which is not fully paid, provided that the refusal does not prevent dealings in shares in the Company from taking place on an open and proper basis.

38. ~~45.~~ The board may also refuse to register the transfer of a certificated share unless the instrument of transfer:

Transfer of uncertificated shares

40. Subject to any applicable restrictions in these Articles, uncertificated shares may be transferred by means of a relevant system in accordance with, and subject to, the Regulations and, accordingly, no provision of these Articles shall apply in respect of an uncertificated share to the extent that it requires or contemplates the effecting of

a transfer by an instrument in writing or the production of a share certificate for such share.

Refusal to register transfers of uncertificated shares

41. Registration of transfers of uncertificated shares may be refused in the circumstances set out in the Regulations, including where the number of joint holders to whom the share is to be transferred exceeds four.

Notice of refusal to register

Transmission

Nothing in these Articles shall release the estate of a deceased member (whether a sole or joint holder) from any liability in respect of any share held by him.

Elections permitted

47. ~~51.~~ A person becoming entitled by transmission to a share may, on production of any evidence as to ~~his~~ their entitlement properly required by the board, elect either to become the holder of the share or to have another person nominated by ~~him~~ them registered as the ~~transferee~~. ~~If he~~ holder. If the person entitled by transmission elects to become the holder ~~he~~ they shall send notice in writing to the Company to that effect. If ~~he~~ the person entitled by transmission elects to have another person registered and the share is a certificated share, ~~he~~ they shall execute an instrument of transfer of the share to that other person. New shares subject to these Articles

50. ~~54.~~All shares created by increase of the Company's share capital, by consolidation, division or sub-division of its share capital ~~or the shall be subject to all the provisions of these Articles, including without limitation provisions relating to payment of calls, lien, forfeiture, transfer and transmission. conversion of stock into paid-up shares shall be subject to all the provisions of these Articles, including without limitation provisions relating to payment of calls, lien, forfeiture, transfer and transmission.~~

Rights and restrictions attached to sub-divided shares

51. A resolution to sub-divide shares may determine that, as between the holders of such shares resulting from the sub-division, any of them may have any preference or advantage, or deferred or other right, or be subject to any restriction as compared with the others.

Fractions arising

52. ~~55.~~Whenever any fractions arise as a result of a consolidation or sub-division of shares under these Articles, the board may on behalf of the members deal with the fractions as it thinks fit. In particular, without limitation, the board may sell shares representing fractions to which any members would otherwise become entitled to any person (including, subject to the provisions of the Act, the Company) and distribute the net proceeds of sale in due proportion among those members, except that if such net proceeds do not exceed £5.00 in aggregate per member such shares may be sold for the benefit of the Company. Where the shares to be sold are held in certificated form the board may authorise some person to execute an instrument of transfer of the shares to, or in accordance with the directions of, the buyer. Where the shares to be sold are held in uncertificated form, the board may do all acts and things it considers necessary or expedient to effect the transfer of the shares to, or in accordance with the directions of, the buyer. The buyer shall not be bound to see to the application of the purchase

Purchase of own shares

~~56. Subject to the Act and these Articles, the Company may purchase any of its own shares of any class and make a payment in respect of the purchase of its own shares whether out of its distributable profits or out of the proceeds of a fresh issue of shares.~~

~~57. Subject to the Act, the Company shall be entitled to purchase the Deferred Shares for a sum of £1 in aggregate paid *pro rata* to each Deferred Shareholder.~~

GENERAL MEETINGS

Annual general meetings 53. ~~58.~~ The board shall convene and the Company shall hold general meetings as annual general meetings in accordance with the requirements of the Act.

Class meetings 54. ~~59.~~ All provisions of these Articles relating to general meetings of the Company shall, mutatis mutandis, apply to every separate general meeting of the holders of any class of shares ~~in the capital of the Company~~, except that:

- (a) the necessary quorum shall be two persons holding or representing by proxy or by representative (in the case of a corporate member) at least one-third in nominal value of the issued shares of the class (excluding any shares of that class held as treasury shares) or, at any adjourned meeting of such holders, one holder present in person or by proxy or by representative (in the case of a corporate member), whatever the amount of ~~his~~ their holding, who shall be deemed to constitute a meeting;
- (b) any holder of shares of the class present in person or by proxy or by representative (in the case of a corporate member) may demand a poll; and
- (c) each holder of shares of the class shall, on a poll, have one vote in respect of every share of the class held by him.

For the purposes of this Article, where a person is present by proxy or proxies, ~~he~~ the person is treated only as holding the shares in respect of which those proxies are authorised to exercise voting rights.

Convening general meetings 55. ~~60.~~ The board may call general meetings whenever and at such times ~~and places~~ as it shall determine. On the requisition of members pursuant to the provisions of the Act, the board shall promptly convene a general meeting in accordance with the requirements of the Act. If there are insufficient directors in the United Kingdom to call a general meeting any director of the Company may call a general meeting, but where no director is willing or able to do so, any two members of the Company may summon a meeting for the purpose of appointing one or more directors.

56. The board shall determine in relation to each general meeting the means of attendance at and participation in the meeting, including whether the persons entitled to attend and participate in the general meeting shall be enabled to do so by

FORM OF GENERAL MEETINGS

Definitions

57. In these Articles:

(a) a *physical meeting* means a general meeting held and conducted by physical attendance by members and/or proxies at a particular place; and

(b) a *hybrid meeting* means a general meeting held and conducted by both physical attendance by members and/or proxies at a particular place and by members and/or proxies also being able to attend and participate by electronic means without needing to be in physical attendance at that place.

Form of general meeting

58. The board may decide in relation to any general meeting (including a postponed or adjourned meeting) whether the general meeting is to be held as a physical meeting or as a hybrid meeting and shall, for the avoidance of doubt, be under no obligation to convene a meeting as a hybrid meeting whatever the circumstances.

Arrangements for hybrid meetings

59. Subject to the requirements of the Act and without prejudice to Article 71, the board may make such arrangements as they may decide in connection with the facilities for participation by electronic means in a hybrid meeting. In the case of a hybrid meeting, the provisions of these Articles shall be treated as modified to permit any such arrangements and, in particular:

(a) references in these Articles to attending and being present at the meeting, including in relation to the quorum for the meeting and the right to vote at the meeting, shall be treated as including participating in the meeting by electronic means;

(b) the meeting shall be duly constituted and its proceedings valid if the chair of the meeting is satisfied that adequate facilities have been made available so that all persons (being entitled to do so) attending the hybrid meeting by electronic means, may:

(i) participate in the business for which the meeting has been convened; and

(ii) exercise their right to speak by being in a position to communicate to all those attending the meeting, during the meeting, any information or opinions which that person has on the business of the meeting,

but under no circumstances shall the inability of one or more members or proxies to access, or continue to access, the facilities for participation in the meeting despite adequate facilities being made available by the Company, affect the validity of the meeting or any business conducted at the meeting, provided that the meeting is quorate;

- (c) all resolutions put to members at a hybrid meeting, including in relation to procedural matters, shall be decided on a poll and such poll votes may be cast by such means as the board in its absolute discretion considers appropriate for a hybrid meeting;
- (d) the board may authorise any voting application, system or facility in respect of the electronic platform for a hybrid meeting as they may see fit; and
- (e) if it appears to the chair of the meeting that the electronic facilities for a hybrid meeting have become inadequate for the purpose of holding the meeting then the chair of the meeting may, with or without the consent of the meeting, pause, interrupt or adjourn the meeting (before or after it has started) and the provisions in Article 83 shall apply to any such adjournment. All business conducted at the hybrid meeting up to the point of the adjournment shall be valid.

Electronic participation

60. In relation to electronic participation at a general meeting, the right of a member to participate electronically shall include without limitation the right to speak in the manner set out in Article 59(b)(ii), vote on a poll, be represented by a proxy and have access (including electronic access) to all documents which are required by the Act or these Articles to be made available at the meeting.

Change in form and/or time of hybrid meeting

61. If, after the sending of notice of a hybrid meeting but before the meeting is held (or after the adjournment of a hybrid meeting but before the adjourned meeting is held), the board considers that it is impracticable or unreasonable to hold the meeting at the time specified in the notice of meeting using the electronic facilities stated in the notice of meeting or made available prior to the meeting, they may change the meeting to a physical meeting, change the electronic facilities (and make details of the new facilities available in the manner stated in the notice of meeting), and/or postpone the time at which the meeting is to be held.

Form of adjourned or postponed meeting

62. An adjourned general meeting or postponed general meeting may be held as a physical meeting or a hybrid meeting irrespective of the form of the general meeting which was adjourned or postponed.

Power of the board and chair to impose requirements and restrictions

63. The board or the chair of the meeting may make any arrangement and impose any requirement or restriction the board or the chair considers appropriate to ensure the security of the hybrid meeting, or the health and safety of those attending it, including, without limitation, requirements for evidence of identity that is:

- (a) necessary to ensure the identification of those taking part and the security of the electronic communication, and
- (b) proportionate to those objectives.

NOTICE OF GENERAL MEETINGS

Period of notice

64. An annual general meeting shall be called by at least 21 clear days' notice in writing. Subject to the provisions of the Act, all other general meetings may be called by at least 14 clear days' notice in writing or by not less than such minimum period as is permitted by the Act.

Recipients of notice

65. ~~62.~~ Subject to the provisions of the Act, to the provisions of these Articles and to any restrictions imposed on any shares, the notice shall be sent to every member and every director. The auditors are entitled to receive all notices of, and other communications relating to, any general meeting which any member is entitled to receive.

Contents of notice: general

66. ~~63.~~ Subject to the provisions of the Act, the notice shall specify ~~the time, date and place of the meeting (including without limitation any satellite meeting place arranged for the purposes of Article 68, which shall be identified as such in the notice) and the general nature of the business to be dealt with;~~

- (a) the time, date and place of the meeting (including without limitation any satellite meeting place arranged for the purposes of Article 69, which shall be identified as such in the notice),
- (b) whether the meeting is a physical meeting or a hybrid meeting;
- (c) where the meeting is a hybrid meeting, details of the facilities for attendance and participation by electronic means at the meeting;
- (d) the general nature of the business to be dealt with; and
- (e) with reasonable prominence, that a member entitled to attend and vote is entitled to appoint one or more proxies to attend, to speak and to vote instead of the member and that a proxy need not also be a member.

Contents of notice: additional requirements

67. ~~64.~~ In the case of an annual general meeting, the notice shall specify the meeting as such. In the case of a meeting to pass a special resolution, the notice shall specify the intention to propose the resolution as a special resolution.

Article ~~70-71~~ arrangements

68. ~~65.~~ The notice shall ~~include details of~~ specify any arrangements made for the purpose of Article ~~70-71~~ (making clear that participation in those arrangements will not amount to attendance at the meeting to which the notice relates).

General meetings at more than one place

69. The board may resolve to enable persons entitled to attend a general meeting to do so by simultaneous attendance and participation at a satellite meeting place anywhere in the world. The members present in person or by proxy or by representative (in the case of a corporate member) at satellite meeting places shall be counted in the quorum for, and entitled to vote at, the general meeting in question, and that meeting shall be duly constituted and its proceedings valid if the ~~chairman~~ chair of the general meeting is satisfied that adequate facilities are available throughout the general meeting to ensure that members attending at all the meeting places are able to ~~participate in the business for which the meeting has been convened. The chair of the general meeting shall be present at, and the meeting shall be deemed to take place at, the principal meeting place.~~

- ~~(a) participate in the business for which the meeting has been convened;~~

~~(b) — hear and see all persons who speak (whether by the use of microphones, loudspeakers, audio visual communications equipment or otherwise) in the principal meeting place and any satellite meeting place; and~~

~~The chairman of the general meeting shall be present at, and the meeting shall be deemed to take place at, the principal meeting place.~~

Interruption or adjournment where facilities where physical meeting place inadequate to accommodate all members

70. If it appears to the chair that the physical meeting place specified in the notice convening the meeting has become inadequate to accommodate all members entitled and wishing to attend, the meeting shall nevertheless be duly constituted and its proceedings valid provided that the chair is satisfied that adequate facilities are available to ensure that any member who is unable to be accommodated is nonetheless able to participate in the business for which the meeting has been convened.

~~67. — If it appears to the chairman of the general meeting that the facilities at the principal meeting place or any satellite meeting place have become inadequate for the purposes referred to in Article 68, then the chairman may, without the consent of the meeting, interrupt or adjourn the general meeting. All business conducted at that general meeting up to the time of that adjournment shall be valid. The provisions of Article 81 shall apply to that adjournment.~~

Other arrangements for viewing and hearing proceedings general meetings

71. 68. The Without prejudice to Article 59, the board may make arrangements for persons entitled to attend and participate in a general meeting or an adjourned general meeting to be able to view and hear the proceedings of the general meeting or adjourned general meeting and to speak at the meeting (whether by the use of microphones, loudspeakers, audio-visual communications equipment or otherwise) by attending at a venue anywhere in the world not being a satellite meeting place. Those If the general meeting is only held as a physically meeting and not as a hybrid meeting, those attending at any such venue shall not be regarded as present at the general meeting or adjourned general meeting and shall not be entitled to vote at the meeting at or from that venue. The inability for any reason of any member present in person or by proxy at such a venue to view or hear all or any of the proceedings of the physical general meeting or to speak at the meeting shall not in any way affect the validity of the proceedings of the meeting.

Controlling level of attendance

72. 69. The board may from time to time make any arrangements for controlling the level of attendance at any venue for which arrangements have been made pursuant to Article 70-71 (including without limitation the issue of tickets or the imposition of some other means of selection) it in its absolute discretion considers appropriate, and may from time to time change those arrangements. If a member, pursuant to those arrangements, is not entitled to attend in person or by proxy or by representative (in the case of a corporate member) at a particular venue, he such member shall be entitled to attend in person or by proxy or by representative at any other venue for which arrangements have been made pursuant to Article 70-71. The board must take reasonable steps to ensure that any member trying to attend the meeting at the original time, date and place and, if applicable, electronic platform is informed of the new arrangements. 74. ~~71.~~ For the purposes of Articles ~~68-69~~, 70, 71-, 72 and ~~72~~73, the right of a member to participate in the business of any general meeting shall include without limitation the right to speak, ~~vote on a show of hands in the manner set out in Article 59(b)(ii),~~ vote on a poll, be represented by a proxy ~~and,~~ have access to all documents which are required by the Act or these Articles to be made available at the meeting, and in relation to physical general meetings, vote on a show of hands.

Accidental omission to send notice etc.

75. ~~72.~~ The accidental omission to send a notice of a meeting or resolution, or to send any notification where required by the Act or these Articles in relation to the publication of a notice of meeting on ~~a~~ the Company's website, or to send a form of proxy where required by the Act or these Articles, to any person entitled to receive it,

or the non-receipt for any reason of any such notice, resolution or notification or form of proxy by that person, whether or not the Company is aware of such omission or non-receipt, shall not invalidate the proceedings at that meeting.

Security and
health and
safety

76. ~~73.~~ The board and, at ~~any a~~ general meeting, the ~~chairman~~ chair, in its or their absolute discretion, may make any arrangement and impose any requirement or restriction ~~it or he~~ the board or the chair considers appropriate to ensure the security or health and safety of a general meeting including, without limitation, requirements for evidence of identity to be produced by those attending the meeting, the searching of their personal property and the restriction of items that may be taken into the meeting place. The board and, at any general meeting, the ~~chairman~~ chair are entitled to refuse entry to a person who refuses to comply with these arrangements, requirements or restrictions.

Orderly conduct

77. The chair of each general meeting of the Company may take such action, or give directions for such action to be taken, as the chair considers appropriate to promote the orderly conduct of the business of the meeting as set out in the notice of the meeting. The chair's decisions on points of order, matters of procedure or arising incidentally from the business of the meeting shall be final, as shall their determination as to whether any point or matter is of such nature.

PROCEEDINGS AT GENERAL MEETINGS

Quorum

78. ~~74.~~ No business shall be dealt with at any general meeting unless a quorum is present, but the absence of a quorum shall not preclude the choice or appointment of a ~~chairman~~ chair, which shall not be treated as part of the business of the meeting. Save as otherwise provided by these Articles, two qualifying persons present at a meeting and entitled to vote on the business to be dealt with are a quorum, unless:

- (a) each is a qualifying person only because ~~he~~ such person is authorised under the Act to act as a representative of a corporation in relation to the meeting, and they are representatives of the same corporation; or
- (b) each is a qualifying person only because ~~he~~ such person is appointed as proxy of a member in relation to the meeting, and they are proxies of the same member.

For the purposes of this Article a “qualifying person” means (i) an individual who is a member of the Company, (ii) a person authorised under the Act to act as a representative of the corporation in relation to the meeting, or (iii) a person appointed as proxy of a member in relation to the meeting.

Adjournment: chairman's chair's powers 82. ~~78.~~ The ~~chairman~~chair may, with the consent of a meeting at which a quorum is present (and shall if so directed by the meeting), adjourn the meeting from time to time and from place to place. ~~No business shall be dealt with at an adjourned meeting other than business which might properly have been dealt with at the meeting had the adjournment not taken place.~~ In addition (and without prejudice to the ~~chairman's~~chair's power to adjourn a meeting conferred by ~~Article 69~~Articles 59(e) and 70), the ~~chairman~~chair may adjourn the meeting to another time and ~~place~~with such means of attendance and participation (including at such place and/or by means of such electronic facility) without such consent if it appears to ~~him~~them that:

84. ~~80.~~ If an amendment is proposed to any resolution under consideration but is in good faith ruled out of order by the ~~chairman~~chair, the proceedings on the substantive resolution shall not be invalidated by any error in such ruling. With the consent of the ~~chairman~~chair, an amendment may be withdrawn by its proposer before it is voted on. No amendment to a resolution duly proposed as a special resolution may be considered or voted on (other than a mere clerical amendment to correct a patent error). No amendment to a resolution duly proposed as an ordinary resolution may be considered or voted on (other than a mere clerical amendment to correct a patent error) unless either:

- (a) at least 48 hours before the time appointed for holding the meeting or adjourned meeting at which the ordinary resolution is to be considered (which, if the board so specifies, shall be calculated taking no account of any part of a day that is not a working day), notice of the terms of the amendment and the intention to move it has been delivered in hard copy form to the office or to such other place as may be specified by or on behalf of the Company for that purpose, or received in electronic form at such address (if any) for the time being specified by or on behalf of the Company for that purpose, or

In applying the provisions of this Article, a demand by a proxy counts (i) for the purposes of paragraph (b) of this Article, as a demand by the member, (ii) for the purposes of paragraph (c) of this Article, as a demand by a member representing the voting rights that the proxy is authorised to exercise, and (iii) for the purposes of paragraph (d) of this Article, as a demand by a member holding the shares to which those rights are attached.

Declaration of result

Withdrawal of demand for poll

Conduct of poll

88. ~~84.~~ Subject to Article ~~87~~89, a poll shall be taken as the ~~chairman~~chair directs and ~~he~~the chair may, and shall if required by the meeting, appoint scrutineers (who need not be members) and fix a time and ~~place~~means for declaring the result of the poll. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.

When poll to be taken

89. ~~85.~~ A poll demanded on the election of a ~~chairman~~chair or on a question of adjournment shall be taken immediately. A poll demanded on any other question shall be taken either at the meeting or at such time and ~~place~~with such means of attendance and participation (including at such place and/or by means of such electronic facility) as the ~~chairman~~chair directs not being more than 30 days after the poll is demanded. The demand for a poll shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll was demanded. Notice of poll

90. ~~86.~~ No notice need be sent of a poll not taken at the meeting at which it is demanded if the time and ~~place~~at means by which it is to be taken are announced at the meeting. In any other case notice shall be sent at least seven clear days before the taking of the poll specifying the time at and ~~place~~means by at which the poll is to be taken.

Effectiveness of special resolutions 91. ~~87.~~ Where for any purpose an ordinary resolution of the Company is required, a special resolution shall also be effective.

VOTES OF MEMBERS

Right to vote on a show of hands 92. ~~88.~~ Subject to any rights or restrictions attached to any shares, on a vote on a resolution on a show of hands:

- (a) every member who is present in person shall have one vote;
- (b) every corporate member who is present by representative shall have one vote;
- (c) ~~(b)~~ subject to paragraph (c) of this Article, every proxy present who has been duly appointed by one or more members entitled to vote on the resolution has one vote;
- (d) ~~(e)~~ a proxy has one vote for and one vote against the resolution if:
 - (i) the proxy has been duly appointed by more than one member entitled to vote on the resolution, and
 - (ii) the proxy has been instructed by one or more of those members to vote for the resolution and by one or more other of those members to vote against it.

Right to vote on a poll 93. ~~89.~~ Subject to any rights or restrictions attached to any shares, on a vote on a resolution on a poll every member present in person or by proxy or by representative shall have one vote for every share of which ~~he~~ such member is the holder, proxy or representative.

Votes of joint holders 94. ~~90.~~ In the case of joint holders of a share, the vote of the senior who tenders a vote, whether in person or by proxy or representative (in the case of a corporate member), shall be accepted to the exclusion of the votes of the other joint holders. For this purpose seniority shall be determined by the order in which the names of the holders stand in the register.

Member under incapacity 95. ~~91.~~ A member in respect of whom an order has been made by a court or official having jurisdiction (whether in the United Kingdom or elsewhere) in matters concerning mental disorder may vote by the member's guardian, ~~whether on a show of hands or on a poll, by his~~ receiver, curator bonis or other person authorised for that purpose appointed by that court or official. ~~That receiver, curator bonis or other and that~~ person may, ~~on a show of hands or on a poll,~~ vote by proxy. The right to vote shall be exercisable only if evidence satisfactory to the board of the authority of the person claiming to exercise the right to vote has been delivered to the office, or another place specified in accordance with these Articles for the delivery of proxy appointments, not less than 48 hours before the time appointed for holding the meeting or adjourned meeting at which the right to vote is to be exercised provided that the Company may specify, in any case, that in calculating the period of 48 hours, no account shall be taken of any part of a day that is not a working day.

Section 793 of the Act: restrictions if in default 97. ~~93.~~ If at any time the board is satisfied that any member, or any other person appearing to be interested in shares held by such member, has been duly served with a notice under section 793 of the Act (a *section 793 notice*) and is in default for the prescribed period in supplying to the Company all or any part of the information thereby required, or, in purported compliance with such a notice, has made a statement which is false or inadequate in a material particular, then the board may, in its absolute discretion at any time thereafter by notice (a *direction notice*) to such member direct that:

Copy of notice to interested persons

98. ~~94.~~ The Company shall send the direction notice to each other person appearing to be interested in the default shares, but the failure or omission by the Company to do so shall not invalidate such notice.

New shares issued in right of default shares

99. Any new shares in the Company issued in right of default shares shall be subject to the same sanctions as apply to the default shares provided that any sanctions applying to, or to a right to, new shares by virtue of this Article shall cease to have effect when the sanctions applying to the related default shares cease to have effect (and shall be suspended or cancelled if and to the extent that the sanctions applying to the related default shares are suspended or cancelled) and provided further that Article 97 shall apply to the exclusion of this Article if the Company gives a separate notice under section 793 of the Act in relation to the new shares.

When restrictions cease to have effect

Board may cancel restrictions

~~96. The board may at any time send a notice cancelling a direction notice.~~

101. The board may at any time send a notice in writing to the holder of the default shares cancelling a direction notice (a *withdrawal notice*). Unless and until a withdrawal notice is duly served in relation thereto or a direction notice in relation thereto is deemed to have been withdrawn or the shares to which a direction notice relates are transferred by means of an approved transfer, the sanctions referred to in Article 97 and Article 99 shall continue to apply.

Conversion of uncertificated shares

Supplementary provisions

- (a) a person shall be treated as appearing to be interested in any shares if the member holding such shares has sent to the Company a notification under section 793 of the Act which either (i) names such person as being so interested or (ii) fails to establish the identities of all those interested in the shares, and

(after taking into account the said notification and any other relevant section 793 notification) the Company knows or has reasonable cause to believe that the person in question is or may be interested in the shares;

- (b) the *prescribed period* is 14 days from the date of service of the section 793 notice; and
- (c) a transfer of shares is an *approved transfer* if:
- (i) it is a transfer of shares pursuant to an acceptance of a takeover offer (within the meaning of section 974 of the Act); or

Errors in voting

Objection to voting

106. ~~101.~~ No objection shall be raised to the qualification of any voter except at the meeting or adjourned meeting or poll at which the vote objected to is tendered. Every vote not disallowed at such meeting shall be valid and every vote not counted which ought to have been counted shall be disregarded. Any objection made in due time shall be referred to the ~~chairman~~chair whose decision shall be final and conclusive.

Voting: additional provisions

~~102. — On a poll, a member entitled to more than one vote need not, if he votes, use all his votes or cast all the votes he uses in the same way.~~

107. If a member or their duly appointed representative or proxy present at a general meeting votes on a poll, such member or duly appointed representee or proxy does not need to use all their votes or cast all the votes in the same way.

Appointment of proxy: form 108. ~~103.~~ The appointment of a proxy shall be made in writing and shall be in any usual form or in any other form which the board may approve. Subject thereto, the appointment of a proxy may be:

Proxies: voting 109. The appointment of a proxy shall be deemed to confer authority to demand, or concur in demanding, a poll and to vote on any amendment of a resolution put to, or any other business which may properly come before, the meeting for which it is given as the proxy thinks fit.

Execution of proxy 110. ~~104.~~ The appointment of a proxy, whether made in hard copy form or in electronic form, shall be executed in such manner as may be approved by or on behalf of the Company from time to time. Corporate representatives

116. ~~111.~~ Any corporation which is a member of the Company (in this Article the *grantor*) may, by resolution of its directors or other governing body, authorise such person or persons as it thinks fit to act as its representative or representatives at any meeting of the Company or at any separate meeting of the holders of any class of shares. A director, the secretary or other person authorised for the purpose by the secretary may require all or any of such persons to produce a copy, or, if required by the board, a certified copy- of the resolution of authorisation before permitting ~~him-~~the person to exercise ~~his-~~their powers. Such person is entitled to exercise (on behalf of the grantor) the same powers as the grantor could exercise if it were an individual member of the Company. Where a grantor authorises more than one person:

Appointment and retirement of directors

Annual re-election

120. Each director shall be subject to annual re-election by the members.

Re-election and retention of office

121. A director who retires at an annual general meeting may, if willing to act, be re-elected. If the director is not re-elected or deemed to be re-elected, such director shall, unless Article 124 applies, retain office until the meeting elects someone in their place, or if it does not do so, until the end of the meeting.

- (b) ~~(e)~~ that person becomes bankrupt or the subject of an interim receiving order or makes any arrangement or composition ~~is made~~ with that person's creditors generally ~~in satisfaction of that person's debts~~ or applies to the court for an interim order under section 253 of the Insolvency Act 1986 (as amended) in connection with a voluntary arrangement under that Act or any analogous event occurs in relation to that person in another jurisdiction;
- (c) ~~(d)~~ a registered medical practitioner who is treating that person gives a written opinion to the Company stating that that person has become physically or mentally incapable of acting as a director and may remain so for more than three months;

Ordinary remuneration

150. ~~141.~~ The ordinary remuneration of the directors who do not hold executive office for their services (excluding amounts payable under any other provision of these Articles) shall not exceed in aggregate £1 million per annum or such higher amount as the Company may from time to time by ordinary resolution determine. Subject thereto, each such director shall be paid a fee for their services (which shall be deemed to accrue from day to day) at such rate as may from time to time be determined by the board.

Additional remuneration for special services

Directors may be paid expenses

152. ~~143.~~ The directors may be paid all travelling, hotel, and other expenses properly incurred by them in connection with their attendance at meetings of the board or committees of the board, general meetings or separate meetings of the holders of any class of shares or of debentures of the Company or otherwise in connection with the discharge of their duties.

EXECUTIVE DIRECTORS

Appointment to executive office

153. ~~144.~~ Subject to the provisions of the Act, the board may appoint one or more of its body to be the holder of any executive office (except that of auditor) in the Company and may enter into an agreement or arrangement with any such director for ~~his~~their employment by the Company or for the provision by ~~him~~such director of any services outside the scope of the ordinary duties of a director. Any such appointment, agreement or arrangement may be made on such terms, including without limitation terms as to remuneration (whether by way of salary, commission, participation in profits or otherwise), as the board determines. The board may revoke or vary any such appointment but without prejudice to any rights or claims which the person whose appointment is revoked or varied may have against the Company because of the revocation or variation.

Termination of appointment to executive office

154. ~~145.~~ An executive director shall not be exempt from annual re-election. Any appointment of a director to an executive office shall terminate if ~~he~~such person ceases to be a director but without prejudice to any rights or claims which ~~he~~such person may have against the Company by reason of such cessation. Emoluments to be determined by the board

155. ~~146.~~ The emoluments of any director holding executive office for ~~his~~their services as such shall be determined by the board, and may be of any description, including without limitation admission to, or continuance of, membership of any scheme (including any share acquisition scheme) or fund instituted or established or financed or contributed to by the Company for the provision of pensions, life assurance or other benefits for employees or their dependants, or the payment of a pension or other benefits to ~~him or his~~such director or their dependants on or after retirement or death, apart from membership of any such scheme or fund.

DIRECTORS' INTERESTS

Authorisation under s175 of the Act

156. For the purposes of section 175 of the Act, the board may authorise any matter proposed to it in accordance with these Articles which would, if not so authorised, involve a breach of duty by a director under that section, including, without limitation, any matter which relates to a situation in which a director has, or can have, an interest which conflicts, or possibly may conflict, with the interests of the Company (a Conflict). For these purposes references to a Conflict includes a conflict of interest and duty and a conflict of duties. This Article does not apply to conflicts arising in relation to transactions or arrangements with the Company which are governed by Article 158.

~~147.~~ A director seeking authorisation for a Conflict shall declare to the board the nature and extent of their interest and shall provide the board with such details of the Conflict as are necessary for the board to decide how to address the Conflict, together with such additional information as the board may request. The relevant director and any other director with a similar interest may, if the other directors so decide, be excluded from the board meeting while the Conflict is under consideration.

Any such authorisation will be effective only if:

- (a) any requirement as to quorum ~~at the meeting at which the matter is considered~~ is met without counting the director in question or any other interested director (together the Interested Directors); and
- (b) the matter was agreed to without ~~their~~ the Interested Directors voting or would have been agreed to if ~~their~~ the votes of the Interested Directors had not been counted.

Terms applying to authorisation under s175 of the Act

157. The board may (whether at the time of the giving of the authorisation or subsequently) make any such authorisation subject to any limits or conditions it expressly imposes but such authorisation is otherwise given to the fullest extent permitted. The board may vary or terminate any such authorisation at any time. Such terms may include, without limitation, terms that:

- (a) the relevant directors will not be obliged to disclose to the Company or use for the benefit of the Company any confidential information received by the director otherwise than by virtue of the director's position as a director, if to do so would breach any duty of confidentiality to a third party;
- (b) the relevant directors be required by the Company to maintain in the strictest confidence any confidential information relating to the Company which also relates to the situation as a result of which the Conflict arises (the *conflict situation*);
- (c) the relevant directors will be required to conduct themselves in accordance with any terms imposed by the board in relation to the Conflict; and
- (d) the relevant directors will be required by the Company to be excluded from any discussion in relation to any matter which may be relevant to the conflict situation, and not to receive any information relating to such matters.

A director shall comply with any obligation imposed on the director by the board pursuant to any such authorisation.

Interim dividends 189. ~~177.~~ Subject to the provisions of the Act, the board may pay interim dividends if it appears to the board that they are justified by the profits of the Company available for distribution. If the share capital is divided into different classes, the board may:

- (a) pay interim dividends on shares which confer deferred or non-preferred rights with regard to dividends as well as on shares which confer preferential rights with regard to dividends, but no interim dividend shall be paid on shares carrying deferred or non-preferred rights if, at the time of payment, any preferential dividend is in arrear; and
- (b) pay at intervals settled by it any dividend payable at a fixed rate if it appears to the board that the profits available for distribution justify the payment.

 - (g) ~~(f)~~ all proxy appointments which have not been used for the purpose of a poll at any time after one month from the end of the meeting to which the proxy appointment relates and at which no poll was demanded.

Presumption in
relation to
destroyed
documents

227. ~~212.~~ It shall conclusively be presumed in favour of the Company that:
- (a) every entry in the register purporting to have been made on the basis of an instrument of transfer or other document destroyed in accordance with Article ~~213-226~~ was duly and properly made;
 - (b) every instrument of transfer destroyed in accordance with Article ~~213-226~~ was a valid and effective instrument duly and properly registered;
 - (c) every share certificate destroyed in accordance with Article ~~213-226~~ was a valid and effective certificate duly and properly cancelled; and

- (d) every other document destroyed in accordance with Article ~~213-226~~ was a valid and effective document in accordance with its recorded particulars in the books or records of the Company,

but:

- (e) the provisions of this Article and Article ~~213-226~~ apply only to the destruction of a document in good faith and without notice of any claim (regardless of the parties) to which the document might be relevant;
- (f) nothing in this Article or Article ~~213-226~~ shall be construed as imposing on the Company any liability in respect of the destruction of any document earlier than the time specified in Article ~~213-226~~ or in any other circumstances which would not attach to the Company in the absence of this Article or Article ~~213-226~~; and
- (g) any reference in this Article or Article ~~213-226~~ to the destruction of any document includes a reference to its disposal in any manner.

NOMINATION NOTICES

Nomination of persons to enjoy Information Rights

228. This Article 228 applies where a member nominates another person to enjoy Information Rights pursuant to section 146 of the Act.

- (a) The Company may prescribe the form and content of Nomination Notices. Unless the Company prescribes otherwise, a Nomination Notice shall:
- (i) state the name and address of the person nominated;
 - (ii) confirm that the member holds shares in the Company on behalf of the person nominated pursuant to the Nomination Notice;
 - (iii) specify whether the person nominated wishes to receive Shareholder Information in hard copy form, in electronic form or by website communication and include any further information which the Company will need in order to use the means of communication specified;
 - (iv) indicate whether the Information Rights are to be enjoyed only by the person nominated, or whether the member giving the notice may also continue to enjoy them;
 - (v) specify the date from which it is to take effect;
 - (vi) specify the date on which it is to cease to have effect, or that it is to have effect until further notice or until the member concerned transfers or ceases to hold any shares in the Company; and
 - (vii) be executed by or on behalf of the member and the person nominated.
- (b) Subject to these Articles, the Company shall give effect to any Nomination Notice received by it in accordance with these Articles but in accordance with

section 146(5) of the Act shall not be obliged to act on a nomination purporting to relate to certain Information Rights only.

- (c) A nomination made by Nomination Notice shall cease to have effect:
 - (i) in accordance with its terms; or
 - (ii) in accordance with sections 148(3), 148(5) or 148(7) of the Act.
- (d) If the Company receives a document which purports to be a Nomination Notice but which does not contain the required information or which is not given in the form prescribed by the Company, the Company shall give effect to it in accordance with section 147(5) of the Act to the extent that it is able to do so and shall notify the member that it is incomplete (and in what respect it is incomplete) and that the Company cannot give full effect to it in its present form.
- (e) The Company shall be entitled to treat a Nomination Notice as surviving a sub-division, consolidation or reclassification of the Company's share capital.
- (f) The Company shall keep a record of all Nomination Notices which are in force.
- (g) The Company shall provide any member, on request and without charge, with a copy of the records of Nomination Notices given by that member in so far as it is able to do so.
- (h) The Company may fix a record date for the enjoyment of Information Rights or for the circulation of Shareholder Information to persons nominated by Nomination Notices.
- (i) Anything to be carried out by the Company in this Articles 228(f) and 228(g) may instead be carried out by the Company through its agents.

Power to dispose of shares of untraced ~~shareholders~~ members

229. ~~213.~~ The Company shall be entitled to sell, at the best price reasonably obtainable, the shares of a member or the shares to which a person is entitled by transmission if:

- ~~(a) during the period of 12 years before the date of the publication of the advertisements referred to in paragraph (b) of this Article (or, if published on different dates, the first date) (the **relevant period**) at least three dividends in respect of the shares in question have been declared and all dividend warrants and cheques which have been sent in the manner authorised by these Articles in respect of the shares in question have remained uncashed;~~
- ~~(b) the Company shall as soon as practicable after expiry of the relevant period have inserted advertisements both in a national daily newspaper and in a newspaper circulating in the area of the last known address of such member or other person giving notice of its intention to sell the shares; and~~

- (a) there has been a period of 12 years during which at least three dividends in respect of the shares have become payable and no dividend has been claimed during that period in respect of such shares (the *relevant period*);
- (b) the Company has, after expiration of the relevant period, sent a notice of its intention to sell such share to the registered address or last known address of the member or of the person entitled to the share by transmission at which service of notices might be effected in accordance with these Articles and, before sending such notice, the Company is satisfied that it has taken such steps as it considers reasonable in the circumstances to trace the member or other person entitled, including engaging, if considered appropriate in relation to such share, a professional asset reunification company or other tracing agent; and
- (c) during the relevant period and the period of three months following the ~~publication of the advertisements referred to in paragraph (b) of this Article (or, if published on different dates, the first date)~~ date of such notice, the Company has received no indication either of the whereabouts or of the existence of such member or person.

Power to dispose of additional shares

230. If, during the relevant period, any additional shares have been issued by way of rights in respect of shares held at the commencement of such period or in respect of shares so issued previously during such period, the Company may, if the requirements of Article 229 have been satisfied, also sell such additional shares.

Transfer on sale

231. ~~214. To give effect to any~~ A sale pursuant to Article ~~215~~229 or Article 230 may be made at such time and price and on such terms as the board may determine and, to give effect to any such sale, the board may:

- (a) where the shares are held in certificated form, authorise any person to execute an instrument of transfer of the shares to, or in accordance with the directions of, the buyer; or
- (b) where the shares are held in uncertificated form, do all acts and things it considers necessary or expedient to effect the transfer of the shares to, or in accordance with the directions of, the buyer.

Effectiveness of transfer

232. ~~215.~~ An instrument of transfer executed by that person in accordance with Article ~~216(a)~~231(a) shall be as effective as if it had been executed by the holder of, or person entitled by transmission to, the shares. An exercise by the Company of its powers in accordance with Article ~~216(b)~~231(b) shall be as effective as if exercised by the registered holder of or person entitled by transmission to the shares. The transferee shall not be bound to see to the application of the purchase money, and ~~his~~ their title to the shares shall not be affected by any irregularity in, or invalidity of, the proceedings in reference to the sale.

Proceeds of sale

233. ~~216.~~ The net proceeds of sale shall belong to the Company ~~which~~. The Company shall be obliged to account to the former member or other person previously entitled for an amount equal to the proceeds. ~~The~~ Until the Company has so accounted, the Company shall enter the name of such former member or other person in the books of the Company as a creditor for that amount. In relation to the debt, no trust is created

and no interest is payable. The Company shall not be required to account for any money earned on the net proceeds of sale, which may be used in the Company's business or invested in such a way as the board from time to time thinks fit. If no valid claim for the net proceeds has been received by the Company during a period of six years from the date upon which the relevant shares were sold by the Company in accordance with these Articles, the net proceeds will be forfeited and will belong to the Company.

WINDING UP

Liquidator may distribute in specie

234. ~~217.~~ If the Company is wound up, the liquidator may, with the sanction of a special resolution of the Company and any other sanction required by the Insolvency Act 1986:

- (a) divide among the members in specie the whole or any part of the assets of the Company and may, for that purpose, value any assets and determine how the division shall be carried out as between the members or different classes of members;
- (b) vest the whole or any part of the assets in trustees for the benefit of the members; and
- (c) determine the scope and terms of those trusts,

but no member shall be compelled to accept any asset on which there is a liability.

Disposal of assets by liquidator

235. ~~218.~~ The power of sale of a liquidator shall include a power to sell wholly or partially for shares or debentures or other obligations of another body corporate, either then already constituted or about to be constituted for the purpose of carrying out the sale.

Third party indemnity provision

236. ~~219.~~ Subject to the provisions of the Act, but without prejudice to any indemnity to which the person concerned may otherwise be entitled, ~~every~~ the Company may indemnify any director ~~or other~~ and officer of the Company (other than any person ~~to~~ whether an officer or not) ~~engaged by the Company as auditor) shall be indemnified or of any associated company~~ out of the assets of the Company against ~~any liability~~ all losses and liabilities sustained or incurred by ~~him~~ that director or officer for negligence, default, breach of duty or breach of trust in ~~relation to the affairs of the Company, provided that this Article shall be deemed not to provide for, or entitle any such person to, indemnification to the extent that it would cause this Article, or any element of it, to be treated as void under the Act or otherwise under the Act.~~ the execution of the duties of their office or otherwise in relation therefore, provided that this Article 236 shall only have effect insofar as its provisions are not void under sections 232 or 234 of the Act.

Pension scheme indemnity provision

237. The Company may also indemnify, out of the assets of the Company, any director or officer of either the Company or any associated company where the Company or such associated company acts as trustee of a pension scheme, against liability incurred by that director or officer in connection with the relevant company's

activities as trustee of such scheme, provided that this Article 237 shall only have effect in so far as its provisions are not void under sections 232 or 235 of the Act.

Definitions

238. For the purpose of Article 236 and Article 237, the expression *associated company* shall mean a company which is either a subsidiary or a holding company of the Company or a subsidiary of such holding company, as such terms are defined in the Act.
